Dear Sirs:

The County of Bergen is seeking an opinion as to whether or not it can award a low bid of \$1,922,794 to APS Contracting, Inc. The County's concern arises from an interrelationship between APS Contracting, Inc. and APS Contractors, Inc. as evidenced by a shared letterhead, a shared address, and shared ownership as set forth herein. Pursuant to a Final Judgement in July 2005 APS Contractors is suspended from bidding on public works for the period June 20, 2005 to June 19, 2006.

By way of background APS Contracting, Inc. of 155-151 Pennsylvania Ave. Paterson, NJ bid \$1,922,794 on October 12, 2005 to construct the County's proposed Hackensack River Pathway. APS Contracting, Inc. 's Contractor Registration Certificate is No. 624992. According to the Bid Proposal and Statement of Ownership Svetozar Savreski and Tadeusz Banasiak, own 10% or more of the corporation. On December 7, 2005, due to a pending NJDEP permit approval the County and the four low biddesr mutually agreed to extend the time to make the award to February 3, 2006.

It has recently come to the County's attention that on July 21, 2005, the State of New Jersey Department of Labor and Workforce Development issued a Final Administrative Action of the Commission against *APS Contractors, Inc.* located at 155-151 Pennsylvania Ave., Paterson, NJ and Goce Blazeski. The Final Order incorporated the Final Revised "Global" Settlement Agreement dated June 2005 in which *APS Contractors, Inc.* and the Respondents voluntarily suspended its Contractor Registration Certificate 599914 and agreed not to bid or contract for any "additional" public work in New Jersey until June 19, 2006.

The County's attention has also been called to Svetozar Savreski's letter dated September 21, 2005 - written on APS <u>Contracting</u>, Inc. 's letterhead - to the Township of Dover stating that Mr. Savreski owns a 90% shareholder interest in APS <u>Contractors</u>, Inc. Mr. Savreski resume, submitted as part of the bid package to the County, omitted mentioning that Mr. Savreski's was both an officer of and a 90% shareholder of a suspended company, to wit: APS Contractors, Inc. It is unclear from the documents in the County's possession if the year long suspension of APS Contractors also involved the suspension of its 90% owner, Mr. Savreski - which would then bar APS Contracting, Inc. from bidding on and/or receiving an award for the County's Hackensack River Pathway.

Enclosed for your review are copies of the APS Contractor's, Inc.'s Final Judgement; "Global" Settlement": APS Contracting, Inc. letter dated September 21, 2005 on behalf of APS Contractor's, Inc.'s; APS Contracting, Inc.'s PWCRA Certificate and Statement of Ownership; and the resume that Mr. Savreski attached to the County's Bid Proposal.



"GLOBAL" SETTLEMENT AGREEMENT

The Parties, referring collectively to Petitioner and Respondents herein, having negotiated and agreed to settle and

therefore resolve all pending prevailing wage and contractor registration matters existing between them as of this date, including the above-captioned matters;

The parties agree to the following terms and conditions of this "global" settlement ("Agreement"):

1. Matters Included: The matters included and therefore encompassed by this Agreement are listed by agency reference numbers: PC-352-0503-KIS, PC-353-0503-KIS, PC-1111-1203-MAN, CR3-599914-04. These matters are all deemed resolved by this Agreement. In entering into this Agreement, Respondents are relying on the Department of Labor's representation that there are no other matters pending at the Office of Wage and Hour Compliance, Public Contracts Section other than the cases referenced above. This settlement is intended to resolve any and all prevailing wage and contractor registration matters involving these Respondents to the date of this Agreement whether or not specifically listed in this Agreement.

2. Monies Due: The Respondents shall pay the total sum of \$150,000 to the "Commissioner" of Labor" in eleven installments the amounts and due dates which are specified below in the following Table of Installment Payments:

Respondents hereby agree that their failure to make any of the foregoing installments on time, "on time" defined as the payment physically at Petitioner's Trenton offices on or prior any of the due dates indicated, may subject any or all of Respondents to be placed on the list of debarred contractors maintained by Petitioner

without any further notice to Respondents, other than Petitioner reasonably double-checking to ascertain that any such payment perceived in default has not in fact been received by Petitioner before exercising this provision. In recognition of the fact that Petitioner has agreed to accept installments in lieu of requiring a lump-sum payment by Respondents at the outset of this Agreement, the purpose of this provision is to provide meaningful incentive for Respondents to continue to make timely payments throughout the payment schedule indicated above, and to further assure that Respondents alone bear the entire risk of any default in payments.

Registration Certificate Number 599914 ("Certificate") held by Respondents in the name of certificate holder "APS Contractors.

Inc." is hereby voluntarily SUSPENDED for a penalty time period of twelve (12) months commencing on June 20, 2005 and ending on June 19, 2006 (referred to as the "voluntary suspension"). Subject to any default in payments specified in paragraph 2 above, or any future prevailing wage or contractor registration violations, petitioner shall not list Respondents as debarred contractors as a result of the voluntary suspension under this Agreement.

certificate Number 599914 to the Commissioner by June 20, 2005, noting that the first installment payment of \$50,000 indicated in paragraph 2 above shall have already been paid to the Commissioner at the time the original certificate is so surrendered.

A. Prohibited Public Work: Respondents may not bid or contract for any "additional" public work in New Jersey for the time period of the voluntary suspension, June 20, 2005 through June 19, 2006. However, Respondents are not precluded from completing any "existing" public work to which Respondents were contractually bound to perform prior to the voluntary suspension, specifically prior to June 20, 2005.

may apply for a new Certificate of Contractor Registration after the voluntary suspension is concluded or upon the normal renewal cycle of such certificate, whichever date is later. Any unexpired term of the certificate after the voluntary suspension will be honored by Petitioner provided Respondents notify Petitioner to return the original certificate for such unexpired term. The violations alleged herein and the successful compliance with the penalties imposed by this Agreement shall not be a basis to demy any such future application for a Certificate by Respondents. However, Petitioner reserves the right to review all such

applications on their merits according to the requirements the law imposes.

The parties acknowledge that the 6. Previous Violation; Respondents deny all of the allegations by Petitioner in this matter and that this Agreement constitutes a settlement of disputed claims solely to avoid the burdens, expenses, and uncertainties of outcome encompassed by litigation. This Agreement is not construed as an admission of guilt or fault on the part of Respondents concerning the contested factual allegations underlying this case as asserted by Petitioner. Notwithstanding, this Agreement and the voluntary suspension and monetary payments it encompasses shall constitute a "previous violation" of Respondents as that term is utilized by the applicable regulations, N.J.A.C. 12:60-7.3 and 12:62-2.1, and may therefore be utilized for penalty assessment purposes in any future prevailing wage or contractor registration cases involving Respondents, if any, should any such future cases ever arise, and for no other purpose. Voluntary suspension means suspension for purposes of previous violation.

7. Failure To Adhers To Agreement: Any failure of Respondents to adhere to the terms of this Agreement, other than default in payments specified in paragraph 2 above, may be the

subject of future action by Petitioner against Respondents, if such rituation should ever arise.

8. Withdrawal Of The Above-Captioned Matter: With full intent to mutually and globally resolve all of the matters pending between them at this time, Raspondents withdraw their appeals in the above-captioned matters, and Petitioner similarly withdraws all of its charges in the above-captioned matters.

WHEREFORE, the Parties, intending to be bound by this Agreement, affix the signatures of their duly-authorized representatives with power and authority to accept and bind the Parties to the terms and conditions of this Agreement:

FINAL ADMINISTRATIVE ACTION OF THE COMMISSIONER

Issued: July 21, 2005

The New Jersey Department of Labor and Workforce Development seeks the debarment of APS Contractors, Inc. and its principals for violating the State's Prevailing Wage Law, N.J.S.A. 34:11-56.25, et seq. The Department also sought to revoke respondents' contractor registration certificate and assessed respondent for wages, fees and penalties related to the violations. The matter was transferred to the Office of Administrative Law for a hearing before Administrative Law Judge (ALJ) Jeffrey A. Gerson. However, prior thereto, the parties entered into a settlement agreement which resolved the issues in controversy. After reviewing the terms thereof and having determined that the parties voluntarily agreed to the settlement agreement, the ALJ signed an Initial Decision dated June 20, 2005. He concluded therein that the settlement agreement met the requirements of N.J.A.C. 1:1-19.1 and should be approved. Accordingly, he ordered the parties to comply therewith.

Having considered the Administrative Law Judge's Initial Decision and, having made an independent evaluation of the record, I have accepted and adopted the findings, conclusion and recommendation as contained in the Administrative Law Judge's Initial Decision. Accordingly, I conclude that the settlement agreement be approved.

ORDER

Therefore, it is ordered that the terms of settlement be approved.

This is the final administrative decision in this matter. Any further review should be pursued in a judicial forum.

The New Jersey Department of Labor and Workforce Development moved to revoke the contractor registration certificate of respondents SMAC Corporation, its president, Svetozar Savreski, and its vice-president, Zlate Geleski, as well as that of APS Contracting, Inc. and its principals. The aforementioned Mr. Savreski, as its president, and Tadeusz Banasiak, a shareholder. The revocation was premised on the fact that Mr. Savreski had failed to disclose his financial interest in APS Contracting, Inc., as well as in three business entities, at the time that he applied for a contractor registration certificate for respondent, SMAC Corporation, as he was required to do pursuant to N.J.S.A., 34:11-56.48, et seq. and N.J.A.C., 12:62-2.4 (a) 3.

The matters were transferred to the Office of Administrative Law, where they were consolidated, for a hearing before Administrative Law Judge (ALJ) Joann Lasala Candido. However, prior thereto, the parties entered into a settlement agreement which resolved the issues in controversy. After reviewing the terms thereof, and having determined that the parties had voluntarily agreed to the settlement agreement, the ALJ signed an Initial Decision dated December 15, 2006 wherein she concluded that the settlement agreement met the requirements of N.J.A.C. 1:1-19.1 and should be approved. Accordingly, she ordered the parties to comply therewith.

Having considered the Administrative Law Judge's Initial Decision and having made an independent evaluation of the record, I have accepted and adopted the findings, conclusion and recommendation as contained in the Administrative Law Judge's Initial Decision. Accordingly, I conclude that the settlement agreement be approved.

"Based on the evidence, work was performed and completed in satisfactory level," he said in an e-mail. "The city's choice to partially re-do APS's work was a completely unnecessary decision."

DEMAREST — The borough has awarded a contract to renovate the inside of the historic railroad station to a new company after the lowest bidder did not sign a contract, according to the borough attorney.

The Borough Council approved a resolution last week hiring L.G. II Co. Inc. of Cedar Grove to perform the improvements at the Park Street depot for \$245,000.

Plans call for the interior walls, ceiling and light fixtures and floors to be replaced, kitchenette and bathrooms to be renovated and the construction of a ticket window built into a new wall. The borough has received a \$349,000 grant from the Federal Highway Administration for the project.

APS Contractors Inc. of Paterson submitted a \$186,500 bid, which had been accepted by the borough in mid-June, Borough Attorney Gregg Paster said.

The contract was sent twice to the company but it was not executed, Paster said.

In a letter sent to the project architect earlier this month, APS said the borough had surpassed a 6o-day deadline from the time bids are received to when a contract must be awarded. An extension of time was not requested.

"APS is not and could not be in default since no consent to an extension of time to consider our bid was requested by the owner and the delay in awarding of the contract was not caused by APS," the letter reads.

Paster said the company's claims are inaccurate and that the bid was awarded within 53 days.

In August, the company received what it said was the first formal correspondence related to awarding the contract — a July 22 letter from the state Department of Transportation to the borough engineer concurring with a recommendation to hire APS, the letter reads.

"APS has never received any contract before that," Goce Blazeski, APS president, wrote in the e-mail.

The Paterson-based contractor Jersey City officials blamed last week for the delayed opening of the Lafayette Pool Complex contends it completed the project successfully.

APS Construction Inc. was awarded roughly \$5.3 million to construct the two pools, originally scheduled to open in April. Opening has been delayed until July, the city says, because of cracks in the plaster that could injure swimmers.

But APS spokesman Goce Blazeski said last week that the "cracking" city officials see in the pools' coating is a "normal characteristic" of all such surfaces. Blazeski said city officials wanted both pools replastered, and APS's subcontractor refused.

"Based on the evidence, work was performed and completed in satisfactory level," he said in an email. "The city's choice to partially redo APS' work was a completely unnecessary decision."

Blazeski added the city owes APS \$500,000, which the company has filed suit to receive.

The city council is scheduled to approve an emergency contract on Wednesday to All State Technology, Inc. of Oak Ridge to replaster the pool.

City spokeswoman Jennifer Morrill said the city cannot comment on APS' allegations because of potential litigation, Morrill said.

Sloppy handling of a lawsuit against one of its major contractors involved in the \$50 million district-wide renovation has prompted the Chathams school district to sue for malpractice, school officials said.

The district had to cough up \$1.4 million in damages and another \$150,000 in interest payments in August to cover costs to Paterson-based APS Contractors after losing a July appellate court decision. The district has been involved in a lawsuit with APS since 2005, according to Ralph Goodwin, the district's business administrator.

Chatham insists it lost its suit and appeal due to the quality of legal work, not the case.

"When we got the appellate decision back, the appellate judges, and this is said by all attorneys who have read this, wrote a decision that clearly outlines the deficiencies of our representation, which made it obvious the board should be considering some kind of case against our attorneys," Goodwin said.

Lead attorney Nuris Portuondo missed deadlines which would have allowed the district to expose contractor faults. "We had an architect and an engineer who did some studies on the quality of the work they performed," Goodwin said.

In one instance APS was "given an allocation of \$5,000 to buy plywood," that was to be used on the middle school roof, he noted. Instead APS "submitted a bill for \$500,000 for plywood."

The experts found stacks of plywood under the middle school roof, but not throughout the entire roof.

"Rather than do a structural thing, they just piled up plywood. The jury made a decision based on what little they knew," he said.

APS abandoned their work in February 2002, despite having a "substantial punch list" of work to do, Goodwin said. The middle school finally got its certificate of occupancy in December 2003. APS was one of several general contractors who were hired to do construction work on the three elementary schools and the middle school. Their specific contract was worth nearly \$6 million.

Portuondo, a lawyer with Schwartz, Simon, Edelstein, Celso & Zitomer in Morristown and who is also a Republican councilwoman in Summit, is being represented by Joseph LaSala, an attorney with the Morristown law firm of McElroy, Deutsch, Mulvaney and Carpenter. The case "is just in its infancy," said La Sala, adding that the defendant "didn't deviate from any standards of legal care."

Asked whether pursuing this malpractice suit might increase the district's legal fees, Chathams Superintendent James O'Neill said malpractice attorneys generally work "more typically on the attorney getting a percentage of the settlement."

The district interviewed a number of attorneys and settled on Rob McAndrews, a Morristown-based attorney. McAndrews said he will seek in excess of \$1.5 million.

"We didn't want to make this a big public thing," said Goodwin. "Apparently their insurance company didn't want to settle."

Money to pay the August bill was taken from reserves and using it "clearly resulted in higher taxes," Goodwin said. He wasn't sure how common these kind of legal fees are.

"Construction is always problematic," said Goodwin, who has been the business administrator for about five years. "The joke in the trade is that you're not finished until you settle the lawsuit."

There were two other contractors used for the extensive renovations and it "ended very amicably. The problem with the public contract laws is that we always have to take the lowest bidder."

"RESPONSIBLE" BIDDER RESOLUTION/ORDINANCE

WHEREAS, the(TOWN/MUNICIPALITY/AGENCY) has a compelling interest in ensuring that contracts for construction projects that it undertakes or for which it provides financial assistance are performed promptly, at reasonable costs and with the highest degree of quality; and
WHEREAS, the(TOWN/MUNICIPALITY/AGENCY) also seeks to ensure that job opportunities generated by contracts as described above are also utilized to help local citizens gain access to employment opportunities; and
WHEREAS, the(TOWN/MUNICIPALITY/AGENCY)finds that it is in its best interest to define the term "responsible" as contained in competitive bidding statutes governing its purchases of construction goods and services; and
WHEREAS, the(TOWN/MUNICIPALITY/AGENCY)wishes to ensure that contracts are awarded in an atmosphere that invites competition and guards against favoritism, improvidence, arbitrary conduct, extravagance, fraud and corruption, so as to secure the best work or supplies at the lowest cost practicable; and
WHEREAS, the(TOWN/MUNICIPALITY/AGENCY)possesses great discretion in determining the "lowest responsible bidder" and is entitled to specify the terms of the contract when its solicits bids and the criteria that bidders must meet in order to be considered a "responsible" bidder in the exercise of its proprietary duties and responsibilities; and
WHEREAS, the contracting authority of the $_$ (TOWN/MUNICIPALITY/AGENCY) $_$ is entrusted with the power to determine whether a respective bidder is the "lowest responsible bidder"; and,
WHEREAS, the(TOWN/MUNICIPALITY/AGENCY)solicits bids and/or proposals on many different types of construction contracts with varying factors affecting each purchasing decision, and therefore must take into account reasonable benefits to the community's welfare arising from each bid and in the exercise of its proprietary functions,
NOW THEREFORE, BE IT RESOLVED THAT financial responsibility is an important factor in determining the lowest responsible bidder, and the(TOWN/MUNICIPALITY/AGENCY),through its contracting authority, shall require an entity that bids on a public construction contract or on a private construction contract that receives financial assistance produce satisfactory evidence that the business entity is properly registered and authorized to conduct the type of work to be performed, including evidence that demonstrates that the entity possesses or complies with all valid licenses, registrations or certificates required by the federal, state, or county law, as well as complying with the general business license requirements of the(TOWN/MUNICIPALITYAGENCY)prior to the award and during the term of the contract,
Additionally, the contracting authority, in order to make its determination as to whether the bidding entity is responsible, shall confirm and substantiate that the contract awardee can reasonably be expected to complete and perform under the contract specifications, and the contracting authority may require the successful bidder to post a bid, performance, wage/fringe benefit and/or material bond(s). The contracting authority shall also determine if the successful bidder can reasonably be expected to complete the project within the time constraints as delineated in the request for bids and/or proposals. The contracting authority shall also determine if the bidding entity maintains a satisfactory level of past performance and integrity as well as possesses the financial, supervisory, personnel, material, equipment, and other resources and expertise to satisfactorily meet its contractual responsibilities and obligations. The contracting authority shall also determine as a condition of being deemed "responsible" that the successful bidder has not been debarred by any federal, state, county or local agency or authority within the past three years or has been convicted of any crime related to the construction business.
BE IT FURTHER RESOLVED THAT social responsibility is a concern in awarding public contracts, and the contracting authority shall factor in its determination of whether a bidder is "responsible" such factors as bidder's record of conformity with environmental, labor, and health and safety laws including compliance with the requirements of the U.S. Department of Labor's Occupational Safety & Health Administration. The bidder and its subcontractors must participate in an apprenticeship program, registered and approved by the United States Department of Labor, for each separate trade or classification for which it employs craft employees. All bidders and subcontractors must continue to participate in such apprenticeship programs for the duration of the project. In addition, the bidder and any and all of its subcontractors, will be required to show that such apprenticeship programs graduated apprentices to journeyperson status for three of the past five years. Furthermore, the bidder shall be required to demonstrate and affirm that it is in compliance with the provisions of N.J.S.A C.34:20-1 et. seq "Construction Industry Independent Contractor Act".
ALSO BE IT FURTHER RESOLVED THAT all bidding entities must provide satisfactory evidence that it provides a benefit configuration being no less than required under N.J.S.A. C.34:11-56,25 et seq., the "New Jersey Prevailing Wage Act" is minimally required to demonstrate that a bidding entity is "responsible". Furthermore, the bidder shall affirm that it has made a good faith effort to provide 40% of all project work hours to residents of(TOWN/MUNICIPALITY/AGENCY) For the purposes of this section, good faith effort, shall constitute a minimum of at least two community job fairs related to the construction of this project and adherence to the aforementioned provisions of being considered a "responsible bidder". That should it be established, after awarding of a contract, that any of the information required by this ordinance and provided by the bidding entity to the(TOWN/MUNICIPALITY/AGENCY) was falsified or inaccurate, the contract shall be voided.
If any provision of the ordinance shall be held to be invalid or unenforceable by a court of competent jurisdiction, any such holding shall not invalidate any other provisions of this ordinance and all remaining provisions shall remain in full force and effect,
The following definitions shall govern this ordinance,

B. Financial Assistance shall mean something of economic value provided by the __(TOWN/MUNICIPALITY/AGENCY)___ to a private entity, expressly articulated or identified in writing by the ___(TOWN/MUNICIPALITY/AGENCY)__, including, but not limited to: loans, loan guarantees, grants, tax exemptions, tax abatements, tax incentive financing, and rent subsidies or reductions approved, funded, authorized, administered or provided by the local government entity or any of its instruments in connection with construction.

A. Public Construction Contract shall mean any public construction project for the construction, reconstruction, demolition or renovation of buildings at the public expense, which it is required by law that workers be paid prevailing wage determined by the Commissioner of Labor pursuant to the provisions of the "New Jersey Prevailing Wage Act," P.L. 1963, c.150(C.34:11-56.25 et seq).
