

If your home contractor is on the list below, there's a chance it ripped you off, the New Jersey Division of Consumer Affairs says.

According to the DCA, it's issued violations to all 62 of these contractors, seeking \$1,046,077.76 in consumer restitution and civil penalties.

It's part of an ongoing crackdown on disreputable contractors, the DCA said.

“Complaints about home improvement contracts are consistently among the top grievances of consumers in the state,” acting Attorney General John J. Hoffman said in an announcement issued Thursday “Disreputable contractors can leave consumers with costs that escalate to the tens of thousands, as well as dangerous conditions that require additional money to repair. The Division of Consumer Affairs continues to ensure that contractors comply with the law and make restitution for shoddy or unfinished work.”

All of the contractors listed below were issued notices during the third quarter of this year. Officials say 23 violated New Jersey law by acting as unregistered contractors. To become registered, a contractor must disclose the physical location of the business and provide proof of a minimum of \$500,000 in liability insurance, among other requirements.

All 62 contractors cited were the subject of consumer complaints, the DCA said. It has ordered them to pay a total of \$803,677.76 in restitution to consumers for alleged slipshod or uncompleted work. The Division has also ordered them to pay a total of \$214,750 in civil penalties ranging from \$1,500 to \$5,750.

It said some cited contractors have cooperated and agreed to consent Orders for the payment of penalties and, in the case of several unregistered contractors, by applying for registration.
