This will confirm and memorialize the terms and conditions discussed and accepted in the course of your recent Pre-hearing Conference.

The Division of Wage and Hour Compliance agreed to revise its initial assessments of:

Wages: \$6,269.00
Admin. Fee: \$1,567.25
Admin Penalty: \$16,250.00

The revised and accepted assessments are as follows:

Wages: \$10,783.24
Admin. Fee: \$2,695.81
Admin. Penalty: \$12,500.00

There will be no debarment sought by the Department of Labor and Workforce Development. However, you must surrender the Contractor Registration Certificate immediately. The revocation of the registration will commence on November 21, 2016 and conclude on August 20, 2017. You are forbidden to bid on any Public Works jobs during the revocation period. Any bids awarded previously can be completed.

This agreement has been reviewed and accepted by the Division with the understanding this matter will be regarded as a "prior offense" for purposes of determining the appropriate penalty for any future violation.

This agreement does not impair any worker's right to pursue a claim for additional wages.
